### Puppy Deposit and Sales Agreement

On this day \_\_\_/\_\_\_/\_\_\_\_\_ Breeder received \$750.00 as a non-refundable deposit to hold a spot in the litter for one Braque Francais puppy.

Puppy pick day is the Saturday after the puppies are 6.5 weeks old. Puppies will be chosen according to the pick order set by the breeder ahead of time. Hunting families do get preference in pick order.

This deposit of \$750 will hold your spot in pick order until the puppies are whelped. The second payment, in the amount of \$750 is expected when puppies are whelped. The 3<sup>rd</sup> and final payment of \$1000 (total puppy cost is \$2,500 not including transportation) is due at puppy pick up. The cost does include worming, 1st set of vaccines, Microchip, NAVHDA registration, and a health guarantee of the puppy. The Breeder will be available to support the Buyer for any questions or concerns that may arise.

This deposit is non-refundable in that the Breeder is not required to return it. Breeder may choose to return the deposit if they feel that circumstances merit a return. Because of the age of the puppies and their developing personalities, it is not possible to guarantee any specific qualities of the dog when it is an adult. If there is not a puppy available of the desired gender, the Breeder will return the deposit before the final sale would otherwise be made and the remainder of the payment received.

If the buyer has made the deposit and later decides they do not want the puppy for any reason, the Breeder is not required to return the deposit. If however, the Breeder has another buyer in line that is interested in said puppy, resulting in a sale of the puppy within a reasonable amount of time from when the first buyer expresses their decision to decline the final sale, the Breeder will still return the deposit.

Overall, the Breeder is not required to return any deposit, but will be understanding in the circumstances and will try to work with a Buyer wanting a deposit returned.

### Puppy Sales Agreement

### Three Day Health Warranty

The purchaser must have the puppy examined by a licensed veterinarian of choice within three days of purchase. If the puppy, in the opinion of the veterinarian, has any physical problems that are life threatening the purchaser has the right to return the dog to the seller within 24 hours from date and time of the veterinarian examination if the purchaser lives within one hour by car of the Seller. Distances over one hour will be agreed upon at the time of sale as written. This puppy must be returned within \_\_\_\_\_. This return will allow the purchaser to receive credit in the amount of the purchase price towards the acquisition of the first available puppy of equal value. You, the purchaser, must bring a signed statement from the Veterinarian showing the date the puppy was examined and the symptoms supporting the opinion. Note: The seller makes no warranty against coccidiosis, hypoglycemia, or worms; this is not a valid reason for return.

### One Year warranty on Life

If the puppy dies of a birth defect within one (1) year the seller will provide a healthy replacement puppy of equal value. To qualify for this warranty the buyer must keep the puppy under the care of a licensed Veterinarian. This care must include all shots recommended by your veterinarian. To make a claim you must bring a veterinarian’s certificate stating cause of death and your puppy’s health records.

### General Terms and Conditions

Failure to have the puppy examined within three (3) days voids all warranties.

**Note: The Seller will make no warranty that you will be able to show or breed this puppy. The Seller does not guarantee the color or size of the puppy.**

The Seller will not be held responsible for any costs accrued after the date of sale. This guarantee is not valid in case of accidental death or injury.

The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog

parasite free and up to date with vaccinations, proper nutrition, which consists of a good quality professional feed given at regular intervals, and fresh water available at all times. The Buyer promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision.

If at any time the Buyer can no longer retain possession of this dog, the Seller is to be notified and given first option of resuming full ownership of the dog for the Seller to locate this dog a new home. Refunds, if any, will be at the discretion of the Breeder/ Seller. The dog will be returned with all registration papers and medical records. Should any circumstances arise that affect the quality of life of the dog, the breeder/seller is to be informed so that they may participate in determining the future of the dog. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.

**Naming the Puppy:** When registering the puppy with any organization their name must end with "of Windy Ridge Gun Dogs". **Purchaser Initials**

**Breeding the Puppy (Dog):** Prior to breeding the Dog, the Purchaser must at 24 months of age, have the Dog's hips and eyes OFA Certified as Good or Pass, respectively. Purchaser shall have written approval from the Seller of the proposed breeding. Purchaser will NOT breed the Dog or to any dog that is not a registered Braque Francais de Pyreneese. Nor shall the Dog be bred to a dog that is NOT a proven bird hunting dog by either NAVHDA testing or personal knowledge. **Purchaser Initials**
